Study Requirements	Eligible undergraduate students must have successfully completed a minimum of two semesters of study before commencing the exchange program.  Upon completion of the exchange program, students are expected to return to their home university to finish their degree requirements.	
GPA	Minimum GPA of 3.0 on a 4.0 scale or equivalent.	
Language Proficiency	An English Proficiency Certificate is required for students from non-English-speaking countries with non-English-medium instruction.  Minimum score: TOEFL:500; IELTS: 5; iBT: 70 or equivalent.

Visa Information		
Application	Universitas Gadjah Mada will facilitate the visa application process. Students will be responsible for a visa fee detailed in their Letter of Offer.  Once approved, the E-Visa will be sent directly to students from our Legal Permit team's email address (itas.oia@ugm.ac.id).	
Fee	The visa fee for a 6-month to 1-year stay is IDR 7,600,000.	
Туре	Students must use a Student Visa (index E30B) for their stay in Indonesia. Those who arrive on a different visa type must depart and re-enter Indonesia with the correct visa.	
Exit Permit	Students planning to depart Indonesia at the end of their studies must report to the Office of International Affairs (OIA) at least two weeks prior to their departure to initiate the Exit Permit (EPO) process.
